ABOUT SPOR AND OSSU

Canada's [Strategy for Patient-Oriented Research](#) (SPOR) is a national collaboration of federal, provincial and territorial partners dedicated to enhancing the integration of research into care. SPOR was created by the [Canadian Institutes for Health Research](#) (CIHR) to integrate funding, research and expertise to foster evidence-informed health care by bringing innovative diagnostic and therapeutic approaches to the point of care to ensure greater quality, accountability and accessibility. SPOR has several elements through which to achieve its goals, including the provincial and territorial SUPPORT Units and national SPOR research networks. The [Ontario SPOR SUPPORT Unit](#) (OSSU) will facilitate the implementation and mobilization of SPOR in Ontario.

Established in 2013, OSSU is a collaboration of 14 leading health research centres, supported by a Coordinating Centre which facilitates, connects and integrates activities across the network. Jointly funded by the Government of Ontario and the Canadian Institutes of Health Research, the initiative engages patients, researchers, clinicians, policy makers, industry representatives and other health system professionals to implement SPOR within Ontario.

DETAILS: EMPOWER Awards

Ontario is home to a wealth of high-quality patient-oriented research, with research teams meaningfully partnering with patients, families, caregivers and communities to deliver rigor, relevance and results from their patient-oriented research projects. For these patient-oriented research findings to enter the evidence chain for changing health policy, practice and health outcomes, there is often a need to support end-of-grant knowledge mobilization activities to build the relationships and push the results to those who can use them to effect real impact and change for Ontario.

In our current health system climate in Ontario, patient-oriented research is more important than ever in informing policy and practice. Research that affects the implementation of change in the health and public health systems can be all manner of health systems, health policy, clinical or public health research that is applicable to our current health system and public health challenges.

CALL FOR PROPOSALS

OSSU is inviting proposals from qualified research teams who can demonstrate the patient-oriented health research they have undertaken (or are undertaking) with patient partners in the last 2 years that would benefit from an injection of knowledge mobilization and/or implementation funding to empower the research to impacts for Ontarians and the Ontario Health System. OSSU welcomes proposals that relate to any project that fits the goal of advancing patient-oriented research.

EXPECTATIONS OF AWARDEES

OSSU's EMPOWER Awards will be expected to complete the following in their funding period:

- At the outset of the funded period, OSSU's Research Centre at the McMaster Health Forum will run a mandatory online training session for all awardees that will cover:
 - Writing policy briefs;
 - Engaging with citizens and plain language outputs;
 - Integrating knowledge users in knowledge translation activities to increase impact; and,
 - Utilizing multiple information and activity streams to support knowledge translation activities.
- All awardees will be required to produce a targeted policy brief around the findings of their POR project that will be developed using integrated knowledge translation approaches.
- Awardees will be expected to produce a diverse set of approaches to knowledge translation that are designed to meet the needs of stakeholders who can make the most impact from the health POR project findings.
- Awardees will be expected to showcase how their proposed research takes into account equity, diversity, anti-racism and anti-indigenous issues.

The OSSU EMPOWER Awards are NOT to supplement research activity funding or to conduct further research based on the initial patient-oriented research project.

FUNDS AVAILABLE

OSSU will allocate up to \$25,000 for the period January 1st, 2022 – June 31st, 2022.

HOW TO APPLY

Proposals should involve two documents:

1. 5-page workplan
2. Budget using the OSSU budget template provided

WORKPLAN

The workplan for the EMPOWER Award proposal should follow the OSSU Workplan Template provided. The workplan must clearly identify:

- Who the PI is; the title of the project that this end of grant award is supplementing; the funding agency; and funding dates of the original project;
- That the EMPOWER Award being applied for is related to a patient-oriented health research project with meaningful patient partnership (through a short patient partner¹ testimony from a partner in the initial project);
- The proposed stakeholders are identified who will be targeted and engaged through the EMPOWER Award to maximize the impact of the POR project;

¹ "Patient" in the terminology of SPOR includes patients, family members, caregivers and community members.

- How patient partners are going to be an integral part of the proposed EMPOWER Award; and,
- How the project will address equity, diversity, anti-racism and anti-indigenous issues faced in Ontario.

BUDGET

Using the budget template provided, prepare the budget. Honoraria or other compensation for patient partners are eligible costs under the OSSU budget process.

ELIGIBILITY

In order to be eligible for this funding opportunity, proposals must identify:

- That the research has taken place in Ontario;
- That the term of the initial research project is no more than 2 years from the start date of the EMPOWER Award funding opportunity (January 2022);
- That the initial research to be translated can demonstrate meaningful patient partnership;
- That the initial research to be translated was NOT funded by the Ontario SPOR SUPPORT Unit as part of its IMPACT Award demonstration projects;
- That the proposed research and knowledge translation team incorporates patient partnership in the proposed activities; and,
- That the nominated principal applicant (NPI) is associated with a CIHR-eligible institution to whom OSSU funds can be flowed.

REVIEW PROCESS AND EVALUATION

Applications received by the closing date will be assessed by a peer-review panel of experts in patient-oriented research, knowledge translation and implementation science. These assessments will consider:

- The quality of the initial patient-oriented health research project that will be built on with the EMPOWER Award (scientific quality, patient partnership approach);
- Extent to which the patient-oriented research findings will be transferrable and scalable to support the Ontario's response to health system and public health challenges (e.g., to practice, programs and/or policy contexts);
- The relevance of the stakeholders implicated in the proposed EMPOWER Award; and
- The appropriateness of the activities outlined in the proposed EMPOWER Award.

Those proposals successfully shortlisted for potential funding will then be assessed by the OSSU Patient Partners Working Group, who will be assessing proposals based on the meaningful engagement of patient partners in the initial research and in the proposed knowledge translation activities, as well as on the potential benefit to patients, families, caregivers and communities of the outcomes of the proposed knowledge translation activities through the Award.

Based on the findings of the expert peer review and the patient partner review, up to four applicants will be selected for funding.
